### Form of Contract Agreement

THIS AGREEMENT, made this 6th day of April, 2018 between **BALANGA WATER DISTRICT** with office address at St. Joseph st., Poblacion, Balanga City represented by its General Manager, **Engr. Charlito G. Rodriguez** (hereinafter called the "Entity") and **FIVE A CONSTRUCTION** with office address at Doña Francisca, Balanga City, Bataan (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **AWARD OF CONTRACT FOR THE SUPPLY OF LABOR, MATERIALS AND EQUIPMENT FOR THE CONSTRUCTION OF BALANGA WATER DISTRICT MULTI-PURPOSE BUILDING, ENGINEERING BUILDING AND WARE HOUSE @EGSA, FOUR-LANES, TUYO, BALANGA CITY, BATAAN** (hereinafter called "the Works") and the Entity has accepted the Bid for **FIVE MILLION FIVE HUNDRED SIXTY THOUSAND SEVEN HUNDRED EIGHT AND 50/100 (P 5,560,708.50)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
  - (a) General and Special Conditions of Contract;
  - (b) Drawings/Plans;
  - (c) Specifications;
  - (d) Invitation to Apply for Eligibility and to Bid;
  - (e) Instructions to Bidders;
  - (f) Bid Data Sheet;
  - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
  - (i) Eligibility requirements, documents and/or statements;
  - (j) Performance Security;
  - (k) Credit line issued by a licensed bank, if any;
  - (l) Notice of Award of Contract and the Bidder's conforme thereto;
  - (m) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.




