- WHEREAS, the Balanga Water District thru its Bids and Awards Committee (BAC), requested various suppliers for the <u>Small Value Procurement</u> of supply and delivery of various fittings for new service connections thru the Request for Quotation No. 2022-003 dated January 04, 2022;
