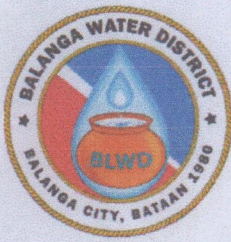

**WHEREAS**, the Balanga Water District thru its Bids and Awards Committee (BAC), requested various suppliers for the **Small Value Procurement** of **supply and delivery of various fittings for rehabilitation of water distribution system at Sibacan, Balanga City, Bataan** thru the **Request for Quotation No. 2022-007** dated **January 10, 2022**;

**WHEREAS**, eight (8) suppliers responded to the invitation; submitted their request for quotation and complied with the eligibility requirements;

**WHEREAS**, of the eight (8) complying suppliers, **Jema Future-Best Enterprise** amounting to **P 67,665.00** submitted the lowest request for quotation inclusive of taxes,
