BOARD RESOLUTION NO. 27 SERIES OF 2022

RESOLUTION APPROVING THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF THREE (3) UNITS UTILITY VAN FOR ENGINEERING AND OPERATIONS DEPARTMENT OF THE BALANGA WATER DISTRICT TO ELITE NORTH AUTOCARS, INC. AMOUNTING TO PHP2,248,500.00.

WHEREAS, the Balanga Water District requested the Local Water Utilities Administration and the Department of Budget and Management for the procurement of three (3) units utility vehicles for the use of Engineering and Operations Department;

WHEREAS, the Department of Budget and Management in its letter to BLWD dated May 20, 2022 approved the purchase of the said vehicles;

WHEREAS, the Balanga Water District thru its Bids and Awards Committee (BAC), advertised the contents of the ITB thru PHILGEPS and BLWD website, and public areas for the competitive bidding of supply and delivery of the three (3) units utility van for Engineering and Operations Department of Balanga Water District thru the Solicitation No. ITB-2022-028 dated June 3, 2022;

WHEREAS, one (1) supplier responded to the invitation; Elite North Autocars, Inc. submitted their quotation and complied with the eligibility requirements amounting to Php2,248,500.00;

WHEREAS, the members of the BAC agreed to adopt Section 36 of RA 9184 and its associated IRR that allows the award of contract to a single calculated/rated responsive bid. The provision instructs the procuring entities to consider a single rated and responsive bid (or single calculated and responsive bid for good and civil works procurement) for award of procurement contracts, and ensure that the ABC reflects the most advantageous prevailing price for the government, provided that the lone bidder meets all the necessary eligibility requirements of criteria and is found to be responsive to the bidding requirements;

WHEREAS, the BAC in its resolution No. 338, dated June 28, 2022 recommended the award of contract to Elite North Autocars, Inc. amounting to Php2,248,500.00;

WHEREAS, the said expenses are included in the 2022 budget and has enough funds to support it as per the attached Certificate of Availability of Funds.


NOW THEREFORE, on motion made and duly seconded, be it **RESOLVED** as it is hereby **RESOLVED** to approve the award of contract for the supply and delivery of three (3) units utility van for Engineering and Operations Department of the Balanga Water District to Elite North Autocars, Inc. amounting to Php2,248,500.00.

RESOLVED FURTHER, to furnish the management of the Balanga Water District copies of this resolution for their information and appropriate action.
