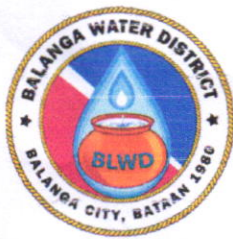

Procurement of ordinary or regular office supplies and equipment not available in the DBM-PS, where the amount involved does not exceed the thresholds prescribed in Annex "H" of this IRR.






