

- WHEREAS, the Bids and Awards Committee is hereby instructed to act upon the BLWD with Purchase Request No. 2023-07-002099 dated June 27, 2023; For supply and delivery of 125-pieces uPVC Main Pipe 2" x 6M Series 10 C-100 with rubber ring and 54-pieces uPVC Main Pipe 3" x 6M Series 10 C-100 with rubber ring for rehabilitation of water supply system at Villa Lina Subd., Phase 1, Brgy. Tenejero, Balanga City, Bataan;
- WHEREAS, the members of the BAC agreed to adopt Section 53.9, Article XVI IRR of RA 9184, Which states the use of <u>Small Value Procurement</u>, a method of procurement of Goods, Infrastructure and Consulting Services where the amount involved does not exceed the thresholds prescribed in Annex "H" of this IRR: Provided, that in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR.
- WHEREAS, the Balanga Water District thru its Bids and Awards Committee (BAC), requested various suppliers for the <u>Small Value Procurement</u> of supply and delivery of 125-pieces uPVC Main Pipe 2" x 6M Series 10 C-100 with rubber ring and 54-pieces uPVC Main Pipe 3" x 6M Series 10 C-100 with rubber ring for rehabilitation of water supply system at Villa Lina Subd., Phase 1, Brgy.
