- WHEREAS, the Bids and Awards Committee is hereby instructed to act upon the BLWD with Purchase request no. 2023-04-001888 with solicitation no. 2023-010 posted on PHILGEPS dated April 21, 2023; supply and delivery of common-use supplies and equipment for office use (good for 6 months);
- WHEREAS, the members of the BAC agreed to adopt Section 52.1(b), Article XVI IRR of RA 9184, Which states the use of <u>Shopping</u>, a method of procurement of goods whereby the Procuring Entity simply requests for the submission of price quotations for readily available off-the-shelf goods or ordinary/regular equipment to be procured directly from suppliers of known qualifications. Procurement of ordinary or regular office supplies and equipment not available in the DBM-PS, where the amount involved does not exceed the thresholds prescribed in Annex "H" of this IRR.
- WHEREAS, the Balanga Water District thru its Bids and Awards Committee (BAC), requested various suppliers / manufacturers for the <u>Shopping</u> of the supply and delivery of common-use supplies and equipment for office use (good for 6 months) thru the Request for Quotation No. 2023-010 dated April 18, 2023;
- WHEREAS, four (4) suppliers / manufacturers responded to the invitation; submitted their request for quotation and complied with the eligibility requirements;
- WHEREAS, of the four (4) complying suppliers / manufacturers, JONIE ROSE TRADING submitted the lowest request for quotation amounting to P 134,467.00 inclusive of taxes,
