BAC Resolution No. 189 Series of 2023

Supply and Delivery of 1-unit Control box 3HP, 30 meters' Submersible cable #12 3/c, 1-unit Submersible electric motor 3HP 230V, Single Phase, 60 cycles suited for 4" diameter well or larger casing & 1-unit Submersible pump stainless steel impeller bowl and shaft suited for 3HP Motor 3450 rpm, 230V, Single Phase, 60 cycles for replacement of submersible pump and motor at San Vicente Pump Station

WHEREAS, the Bids and Awards Committee is hereby instructed to act upon the BLWD with Purchase request no. 2023-12-002545 with solicitation no. 2023-041 posted on PHILGEPS dated December 14, 2023; For supply and delivery of 1-unit Control box 3HP, 30 meters' Submersible cable #12 3/c, 1- unit Submersible electric motor 3HP 230V, Single Phase, 60 cycles suited for 4" diameter well or larger casing & 1-unit Submersible pump stainless steel impeller bowl and shaft suited for 3HP Motor 3450 rpm, 230V, Single Phase, 60 cycles for replacement of submersible pump and motor at San Vicente Pump Station;

WHEREAS, the members of the BAC agreed to adopt Section 53.1, Article XVI IRR of RA 9184, Which states the use of Negotiated Procurement – Two Failed Biddings, a method of procurement of Goods, Infrastructure and Consulting Services where there has been failure of competitive bidding or Limited Source Bidding for the second time as provided for in Section 35 of RA 9184 and its IRR.

WHEREAS, the Balanga Water District thru its Bids and Awards Committee (BAC), requested various suppliers for the supply and delivery of 1-unit Control box 3HP, 30 meters' Submersible cable #12 3/c, 1- unit Submersible electric motor 3HP 230V, Single Phase, 60 cycles suited for 4" diameter well or larger casing & 1-unit Submersible pump stainless steel impeller bowl and shaft suited for 3HP Motor 3450 rpm, 230V, Single Phase, 60 cycles for replacement of submersible pump and motor at San Vicente Pump Station thru the Request for Quotation No. 2023-041 dated December 20, 2023;

WHEREAS, no bid was received when the deadline for submission of bids lapsed on December 06, 2023 first posting and December 19, 2023 second posting;

WHEREAS, under section 35.1 (a) of the IRR of RA 9184, the BAC shall declare the bidding failure, when no bids were received;

WHEREAS, the procuring entity look for three (3) suppliers who responded to the invitation, submitted their request for quotation and complied with the eligibility requirements;
