

# SECURITY SERVICE CONTRACT

## KNOWN ALL MEN BY THESE PRESENTS:

This CONTRACT OF SECURITY SERVICES made and executed by and between **LAUDEREZ SECURITY AND INVESTIGATION SERVICE**. A duly organized and existing under and by virtue of Philippine laws, with principal Office at Villegas Place 2<sup>nd</sup> Floor Unit V, Parang-Parang, Orani Bataan. Represented herein by its Asst/Gm/Operation Manager **Mr. Rogelio R. Lauderez**, herein after referred to as the Representative of the **AGENCY**.

-And- **BALANGA WATER DISTRICT**, represented herein by its General Manager,

**ENGR. CHARLITO G. RODRIGUEZ** here in after referred to as **CLIENT**, with its principal office at EGSA, Tuyo, Balanga City, Bataan.

## WITNESSETH:

WHEREAS, the **CLIENT** is desirous of engaging the services of the **AGENCY** for the purpose of providing adequate security and protection.

WHEREAS, the **AGENCY**, which is duly licensed and Authorized by the law to render protective services, has agreed to provide such services under the terms and conditions herein set forth.

NOW, THEREFORE, for and consideration of the mutual premises, covenants and stipulation hereinafter set forth, the parties hereto enter this **CONTRACT** as follows:

1. The **AGENCY** shall provide the **CLIENT** with qualified, uniformed armed security guards as maybe required by the **CLIENT** from time to time. The **AGENCY** represents and warrants that all guards assigned to the **CLIENT** have been processed, screened by the Philippine National Police, National Bureau of Investigation and issued clearances and licenses as well as permits by the Authorities concerned, and in general, have been lawfully authorized to perform their duties as required under this contract.

2. As required by the **CLIENT**, the security guards to be furnished by the **AGENCY** shall initially consist of **THREE (3) SECURITY GUARDS**, which include service firearms. This number maybe increased or decreased at the sole discretion of the **CLIENT** upon Ten (10) days written notice to the **AGENCY**.

3. It is fully understood that the **AGENCY** is an independent contractor, and such, it binds itself to comply with all requirements of pertinent laws and regulation affecting its business, to fill all returns and reports as maybe imposed on it. The **CLIENT** is only interested in the result of the services furnished by the security guards.

4. The **AGENCY** hereby represents and agrees to furnish the number of guards requested by the **CLIENT** and to serve the **CLIENT** interest in a manner consistent with the laws and the recommendations authorized representative. The **AGENCY** does not undertake to be the insurer of life and property within the premises, but extra ordinary diligence is required to be exercised by the licensed security guard.
