AFFIDAVIT

2. I am granted full power and authority to do, execute and perform any and all acts necessary and/or to represent 2J's DESIGN AND CONSTRUCTION. **in the bidding SUPPLY, DELIVERY, INSTALLATION OF FILTER MEDIA (SHP) FOR PTO. RIVAS LOTE 3 PUMP STATION for BALANGA WATER DISTRICT.**
3. **2J's DESIGN AND CONSTRUCTION** . is not "blacklisted" or barred from the bidding full power Government of the Philippine or any of its agencies, offices, corporation, or Local Government Units, Foreign Government/Foreigner International financing Institutions whose blacklisting rules have been recognized by the Government Procedure Policy Board;
4. Each of the documents submitted in satisfaction of the bidding requirements is an authentic copy of the original, complete and all statements and information provided therein are true and correct.
