### RESOLUTION NO. 08 Series of 2020

#### RESOLUTION APPROVING THE BLWD'S IMPLEMENTING GUIDELINES TO COMBAT THE SPREAD OF CORONA VIRUS 2019 (COVID-19)

**WHEREAS**, the Department of Health (DOH) has confirmed the local transmission of the Corona Virus Disease 2019 (COVID-19). President Rodrigo Roa Duterte, through Presidential Proclamation Nos. 929 and 922 (s.2020), has declared a State of Public Health Emergency throughout the Philippines, and has imposed an Enhanced Community Quarantine and Stringent Social Distancing Measures over the entire Luzon, effective 12:00 AM of 17 March 2020, and expiring on 12:00 AM of 13 April 2020.

**WHEREAS**, to comply with the said directives, the management presents an implementing guidelines that tackles among others, the following conditions:

- a. A work from home arrangement shall be implemented and maintain a skeletal work force that will ensure the delivery of water services 24/7 to our consumers;
- b. Office collection shall be suspended from 18 March 2020 to 12:00 am of April 13 2020. Payments made thru the accredited collection agents shall be honored
- c. Imposition of penalties during the said period shall be waived. Likewise, disconnection of services of delinquent consumers shall be deferred.
- d. On-going infrastructure projects of the WD shall be suspended and will resume implementation on April 13, 2020 or earlier if the Enhanced Community Quarantine is lifted, whichever comes earlier. Applications for new connections shall still be accommodated.
- e. Should the Enhanced Community Quarantine persist beyond April 13, 2020, a new guideline will be issued to move forward.

**WHEREAS**, the Board deemed that the implementation of the said implementing guidelines will be the BLWD's contribution in the government's effort to combat the spread of the COVID – 19.

**NOW THEREFORE**, on motion made and duly seconded, be it resolved as it is hereby resolved to approve the BLWD's implementing guidelines to combat the spread of Corona Virus 2019 (COVID-19):


**RESOLVED FURTHER**, that the BLWD's implementing guidelines be made an integral part of this resolution.

**RESOLVED FINALLY**, to furnish the management of BLWD and the concerned personnel copies of this resolution for their information and appropriate action.


