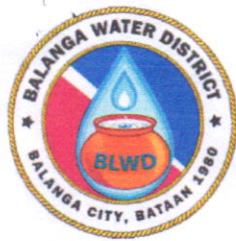




**NOW THEREFORE**, We, the members of **Bids and Awards Committee**, hereby **RESOLVE** as it is hereby **RESOLVED**;




