Supply of preventive maintenance service including oil and filter replacement of nine (9) units of generator set of various pump stations at Balanga Water District.

WHEREAS, the Bids and Awards Committee is hereby instructed to act upon the BLWD with **Purchase Request No. 2024-06-003015** posted on **PHILGEPS** dated **June 10, 2024**; For **supply of preventive maintenance service including oil and filter replacement of nine (9) units of generator set of various pump stations at Balanga Water District**;

WHEREAS, the members of the BAC agreed to adopt **Section 53.9, Article XVI IRR of RA 9184**, Which states the use of **Small Value Procurement**, a method of procurement of Goods, Infrastructure and Consulting Services where the amount involved does not exceed the thresholds prescribed in Annex "H" of this IRR: Provided, that in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR.

WHEREAS, the Balanga Water District thru its Bids and Awards Committee (BAC), requested various suppliers for the **Small Value Procurement** of **supply of preventive maintenance service including oil and filter replacement of nine (9) units of generator set of various pump stations at Balanga Water District** thru the **Request for Quotation No. 2024-024** dated **June 07, 2024**;

WHEREAS, five (5) suppliers responded to the invitation; submitted their request for quotation and complied with the eligibility requirements;

WHEREAS, of the five (5) complying suppliers, **Power Access Electrical Services** submitted the lowest request for quotation amounting to **P 174,000.00** inclusive of taxes,

WHEREAS, the said quotation is within the **BLWD Approved Budget CY 2024** and within the **Approved Budget CY 2023 level**;




NOW THEREFORE, We, the members of **Bids and Awards Committee**, hereby **RESOLVE** as it is hereby **RESOLVED**;


