AFFIDAVIT

I, **Pamela F. Agapito**, of legal age, **Married, Filipino**, and residing at **3F Pinatubo St., Mandaluyong City, 1550 Philippines**, after having been duly sworn in accordance with law, do hereby depose and state that:

1. I am the duly authorized and designated representative of **Riddhi and Zarana Enterprises Corp.** with office address at **Poblacion, Bustos, Bulacan, 3007 Philippines**;
2. I am granted full power and authority to do, execute and perform any and all acts necessary to participate, submit the bid, and to sign and execute the ensuing contract for **RFQ - Supply, Delivery, Installation, Testing and Commissioning of Variable Frequency Drive (VFD) Assembly full set with complete accessories for 15HP Submersible motor, 230V, Three Phase Input 220-24 (2024-037)**, of the **BALANGA WATER DISTRICT**, as shown in the attached *Secretary's Certificate*.

4. Each of the documents submitted in satisfaction of the bidding requirements is an authentic copy of the original, complete, and all statements and information provided therein are true and correct.
5. **Riddhi and Zarana Enterprises Corp.** is authorizing the Head of the Procuring Entity or its duly authorized representative(s) to verify all the documents submitted.
6. None of the officers, directors, and controlling stockholders of **Riddhi and Zarana Enterprises Corp.** is related to the Head of the Procuring Entity, members of the Bids and Awards Committee (BAC), the Technical Working Group, and the BAC Secretariat, the head of the Project Management Office or the end-user unit, and the project consultants by consanguinity or affinity up to the third civil degree;
7. **Riddhi and Zarana Enterprises Corp.** complies with existing labor laws and standards; and
8. **Riddhi and Zarana Enterprises Corp.** is aware of and has undertaken the responsibilities as a Bidder in compliance with the Philippine Bidding Documents, which includes:

 - b. Acknowledging all conditions, local or otherwise, affecting the implementation of the Contract;

full set with complete accessories for 15HP Submersible motor, 230V, Three Phase Input 220-24 (2024-037).

9. Riddhi and Zarana Enterprises Corp. did not give or pay directly or indirectly, any commission, amount, fee, or any form of consideration, pecuniary or otherwise, to any person or official, personnel or representative of the government in relation to any procurement project or activity.

In case advance payment was made or given, failure to perform or deliver any of the obligations and undertakings in the contract shall be sufficient grounds to constitute criminal liability for Swindling (Estafa) or the commission of fraud with unfaithfulness or abuse of confidence through misappropriating or converting any payment received by a person or entity under an obligation involving the duty to deliver certain goods or services, to the prejudice of the public and the government of the Philippines pursuant to Article 315 of Act No. 3815 s. 1930, as amended, or the Revised Penal Code.
