AFFIDAVIT



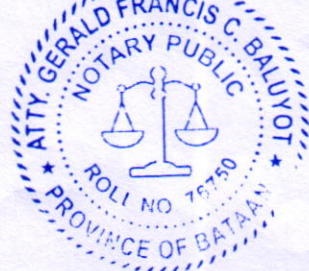


