AFFIDAVIT

None of the officers, directors, controlling stockholders of **FLOW HARMONIC COMMERCIAL, INC.** is related to the Head of the Procuring Entity, members of the Bids and Awards Committee (BAC), the Technical Working Group, and the BAC Secretariat, the head of the Project Management Office or the end-user unit, and the project consultants by consanguinity or affinity up to the third civil degree;
