**WHEREAS**, the Bids and Awards Committee is hereby instructed to act upon the BLWD with **BLWD Project Identification No. 2025-01** dated **May 26, 2025**; For the “Procurement of labor, materials and equipment for the construction of Balanga Water District Conference Building (Eduardo P. Tuazon Hall)”;

**WHEREAS**, the members of the BAC advertised the Invitation to Bid for the above stated contract posted at the website of the BLWD, PHILGEPS, and at three (3) conspicuous places starting on May 26, 2025;
